Training & Safety - Steve

There will be a Wilderness First Aid session coming up in November.

The Forest Service recently had a saw accident. An A cutter being supervised by a B cutter.

Steve reviewed "lessons learned" regarding saw safety as a result of this accident.

Bob discussed a new opportunity regarding a closed campground due to massive blow downs.

This might be a good place for the PCTA to do some practice with cross cut instruction. Could possibly arrange something for September or October. Most ideal for the "100" series course.

We could also consider certifying people if there is enough demand.

Jerry – Dave handed out the first set of finished underbuckers to the group. Nothing to report from Jerry.

Roberta had a question about radios – she ran out of radios to dispense to work parties last week. Dave has submitted a grant proposal for 4 more radios. We currently have 3 in Roberta's cache. Please be aware if you are checking out radios as to whether other work parties are going out at the same time.

Volunteer Coordinator

Tammy – wanted some feedback on how the emails were going out requesting volunteers for work parties.

We currently have 628 people on our volunteer list, but we have gotten very few responses to emails.

Roberta brought up the possibility of putting up a volunteer google calendar to hopefully bring in more volunteers.

There was some discussion about emailing out JHA's (or a link to the JHA;s) to work crews before the trip. Crew Leaders are responsible for doing this as there are different JHA's that need to be sent out depending on the work being done.

TSC

Tammy – Ryan sent out an email asking for volunteers for 2012 TSC. They are still searching for a Chairperson. The date of the event will be April 20-22, 2012.

Roundtable

Steve - a logger was doing some blasting east of 3 Corner Rock that caused a slide over the PCT. An alternate route was established. He also asked group if anyone was interested in taking his section.

Steve – 46 trees down on his section.

Jerry – got an email that Jacquelyn Oakes (?) is retiring at the end of August.
