Crews and Events since last caretaker meeting:

- 1. March 12: Scout Herman Creek Trail: Rick
 - Rick: We had the work party already. The following weekend, March 25. Kelley and I took 5 Mazamas up. It was a pretty good turnout for them. They worked their behinds off on the Herman Creek Loop. Bill and David, Pace and Kelley were involved. Last year it took 4 weekends, we did the whole thing in 1 day this year. Every vine maple had sagged into the trail. It took a lot of time, it was a long day. It snowed and rained on us. I got another guy recruited, Seth, he looks like a guy from ZZ Top. He signed up for all 3 days of TSC. It was a great day. Thank you Kelley for helping out.
- 2. March 12: Scout Herman Bridge Trail/PCT North: Roberta
 - Roberta: Looking to see what was down. The washout needs work and I think we'll do a work party on there. I think on the North side it is coming down.

3. March 14: Eagle Creek Trail Tread Cleanup: Pace & Little Brown

- Pace: On the 14th we had lower ¼ mile with 6" layer of muck on it. The following Thursday, 2 big logs. 1 at the entrance and one a mile up. It was a long day. And then on the 18th we cleared out up to Tish Creek, up to the slide. Tomorrow is our next log out to clean the slide out. On the 23rd we worked at Tish Creek. On the 28th we scouted Teakettle. On the 4th we logged out 23 logs. Most of the stuff is on the lower end. Herman Creek and Teakettle are cleaned. There were 2 wilderness signs on Teakettle, leftover from 2009. We removed them and the signs are at Pace's house.
- Frank: Never volunteer to carry a trail sign until you've tested how heavy it is.
- Pace: I was scouting the last log out on Eagle Creek, walking back from Fern Creek. There looked like an odd rock on the trail and it was a trail post. Only top 4" sticking out. I took a pic and sent to Edan who forwarded to an archeologist.
- 4. March 16: Eagle Creek Trail Logout #1: Pace and Little Brown
 - See above. March 14
- 5. March 21: Logout BOG Oregon Side, Herman Bridge Trail, Herman Creek near TH: Little Brown and Tyler
 - Tyler: There was a new tree that came down 1.5 mile in. It took 7 cuts. You cut it and it would slide down and pinch. We just fought it all day. Bill went on and came out the other side and we went around to pick him up.
 - Roberta: Tyler got one and Bill got 14. I loved that tree by Herman Bridge.
 - Tyler: That's something we should think about doing, there is an ugly splinter about 6 feet high. It's going to come off at some point. It should come down. The piece it is hanging from is 10 or 12 feet up. I could bring my spikes and climb the tree.
 - Roberta: I don't think that's in our JHAs

8. March 25: OSU Tree School: Steve Plant, David

Steve P: It was Tree School. It was pretty slow, 4 signups. Not worth going next year. Those people aren't
really there for our kind of work. Everyone has sons, daughters, someone that's hiked the trail. It's not
really our type of crowd. Although, Clarks Lawn and Garden the OHSU Master Garden tables will wonder
where I am. I am always between them.

9. March 25: Get Ready to Backpack events at REI: Tammy

- Tammy: We had Terry Hill at this REI, I went to Tualatin. They took away my table before I got there, they thought I would be there at 11 but it was 12. I got 6 or 8 sign ups. Terry filled 4 pages. He loved it. He really enjoyed talking to all the people. He has not done one by himself. He did do ALDHA-West, that was pretty contained and pretty easy. - Dave: The Forest Service rewriting their training manual and we have a volunteer photographer, they requested he take as many pics as he could for their training manual. He did a good job. It was 4 days long. It is mixed, PCTA and Forest Service. Same amount of each. The weather was iffy. The first day was hard rain off and on, the 2nd day we had to close up due to the rain. It was too dangerous being on the road going up the hill. The first class of a certs had to double up on Saturday. On Saturday we had snow coming down. For those that held out, we had beautiful sunny weather on Sunday. We got it all in, but just barely. It was a very successful training. It was also the first pilot at qualifying fellers in our program, Pace Leif, David did that. Our intention is to very slowly expand that program.

• Tyler: That was pretty simple. The trail is trashed. Lots of limbs. Few trees but nothing big. It was pretty simple. If you go down I-84 the trees are stripped.

Pace: I finally got on my trail. Planned on hiking in from gate but the Forest Service opened the gate. There were a couple of snow fields that would hang up a low car. I was first person this year in the parking lot. The Sandy River Trail is pretty much bare. The second half is patchy snow. The first reroute needs some more tread work, the second one had a patch of snow so people followed the old so I blocked off the old route. Hopefully this weekend people will get in and follow the new route. Got to the river crossing and the river hasn't changed from last year. That's not saying the spring melt won't change it. No problem walking across. I got to the PCT and there was about 1-2 feet of snow at the junction. No big logs down, just a few small ones on the reroute.

Reports

Volunteer Coordinator: Tammy

Tammy: You guys have been busy. I have a couple of emails because people saw you out in Dry Creek and it hadn't been published and they asked how come I didn't send out the email and they wanted to go out and work on the trail. So people are noticing that you are out there. I was going to, when I come back, I was going to do a couple of volunteer recruitments at REI. So I'll do it in June when I get back. There's a few things going on, they are not certain. People are doing PCT presentations and REI wants us there.

Partnership Crews: Jayme

Upcoming and New:

- 1. PGE at Timothy Lake: New Parks Department liaison is Bacon Bit. Little Brown and Tim to lead.
 - a. Tim L: Bill and I have been in contact with Bacon Bit regarding the PGE crew. We'll wait until the snow melts. Still 4 feet of snow at the end of March.
 - Roberta: When I did it, I had a camp host so there is extra logistics. This is a campsite that other people can reserve so you have to pick a date to reserve the campsite.
- 2. Wilderness Stewards, possibly April/May timeframe after their training. Chris K will lead.

 - Worm: I will do an introduction email.

Dana:

- Dana: Just a few updates on stuff I've been working on. I went on 3 different trips in March. Believe or not there is a week-long training in Visual Resources Management. It's about how to preserve the scenery around trails by disguising developments. We had a Professional Trail Builders Association I went to and a staff retreat. Mike Dawson is retiring in one year. He has been looking toward retirement for a while now and now we have a date but he is going to stay on - he's the director of Trail Ops - he will come back as a 20% part time consultant to finish up some projects. So we are excited for him and in discussion for succession planning for Mike. We don't know if we will replace with another "Mike" or restructure the position. We'll see. We also had a New Marketing and Communications Director, Scott Wilkinson, he is working for us out of Eugene. He has been a marketer for a lot of organizations and he is an avid backpacker. He is coming up with a new updated look for PCTA, including a new logo and promo materials. We are looking forward to how that rolls out. I think he will unite a lot. I've also been working on, we did get funded to complete an EPA study for Mt Jefferson relocations and I'm really happy because there are a couple of spots that the trail had eroded severely and needs rerouting. It's easier to get grants for construction but for the environmental is harder. This summer we have 4 weeks' worth of corp crew. We are adding PCTA volunteers to this. There is still room on those crews building new routes on Jefferson. Hoping to complete in 2018. Roberta and I looked at a BPA power line on Dry Creek Trial. They are upgrading the gravel road to replace the poles, the upgrade will have a pretty visual impact on the trail. We negotiated with them and maybe moving the trail, they are giving us \$5k to study moving the trail down so you don't see the power corridor. North Bonneville, you can't access Table Mountain by the Bonneville Hot Springs anymore. Shelley Lane is a private road and the owners have been unhappy with the public abusers using their private road and leaving trash. Spread the word. There is no public parking. The city is trying to go through the legal channels to create a legal access from downtown. That will be several years in the making, they need a bridge. Shelley Lane residence agreed that we can park there if we make special signage, official PCTA maintainer or PCTA work party, for our vehicles so the public knows we are different and special.
 - Kelley: I had a long talk with Linda, there is a parking area by the slough and went up through the gate and you can access through there. Only 4 cars will fit.
 - Leif: It's kind of in between the hot springs and the power lines and you go through the gate and up the hill and bee-line through the woods.

- Dana: That was goes through private property and we don't have permission.
- Leif: We can park everyone somewhere and then carpool up with PCTA cars and then we limit cars.
- Dave: I have talked with Roberta about magnetic signs for our vehicles. Sounds like something like that would work with a PCTA logo and Trail Crew.
 - Dana: I was thinking of putting it in the window so it doesn't get stolen. And another sign to put up
 while we are parking there that says no parking except...
 - Roberta: We did the magnetic signs for another org, and they don't last long.
- Dana: We've talked about the Timber Trail, the mountain bike trail, getting some traction. I did meet with the main organizer, it's still just a theory. A few places they were too close or on top of the PCTA and I met with the guy and he's really interested in making sure they have the right messaging to make sure his users understand the no bikes on PCT. He's in touch with our marketing people. I think it is great there is a mountain bike opportunity so they don't have to use the PCT. There is a board walk section by Timothy Lake that is shared. I pointed it out, the Forest Service asked me if I had any issues with the Timber Trail and that's the only exception on the whole PCT. We'd like to see some solution there.

<u>Bill</u>: We have our Sasquatch Crews in Goat Rocks full but still need 6 volunteers for the Riley Creek Project 9/15/2017 - 9/21/2017. Camping at Sheep Lake where we did about 6 years ago

- Roberta: It is close to Brooke's section. Riley Creek Trail is the border between north and south Mt Adams sections.
- Dana: It is drop dead gorgeous spot.

- Leif: We got them. Will need all the saw equip for TSC. So anything needing sharpening, we'll be doing that.
 - Roberta: We couldn't find the little tote labeled Wind River.
 - Little Brown: Not sure if I brought it back last fall.
- Marijke: If you need anything at Trout Lake, I can check.

Trail Skills College Apr 28-30 2017: Tammy

- Tammy: Registration closed 2 days ago. Not completely full. We have a bunch of agency people that are waitlist we are going to move around that will make it full. The camping and cooking class didn't get full so I can go to it now. It's like 97% full. Nothing earth shattering is happening.
- Leif: Keep me posted about your trail, we may want to use it for training. Wind River is in May, the first weekend.

Saw Certification: David

David: We already covered Estacada. I spent March 27 in Sierra National Forest. I went to the National Saw Conference. We normally send 2, it was supposed to be Jennifer and me. She got ill. So I ended up representing the PCTA. They talked a lot, 5 full days, most of it had to do with implementing the new national policy. You will start to see the stuff immediately in training and in our JHAs and possibly in other places. The Forest Service is implementing a mandatory 5-step process for buckers and fellers. If you take our classes you will be introduced to that process. We updated the PCTA JHAs to include that process to remind you to use the 5-step process. We also issued trail wide JHAs. You can use the same in Southern California or in Northern Washington. We can use them in training so they become familiar. We reviewed their new complexity. It's what we've been doing. They will provide all kinds of printed material to help us assess the complexity. They are doing a whole new training manual. That will probably be available for our saw classes next year. The database for the national sawyer certificate is not yet online. Not yet being developed. Someone at the Forest Service forgot to put in the request for the funds. They are just getting funding now. For the remainder of 2017 there will be no database. We will continue to use our spreadsheet. Starting next year, we won't keep track of it at PCTA, it will be on the database and can get printouts. Potential impact: all the agents were asked consider the budget and impact if the Forest Service discontinues usage of the Stihl brand chainsaws. We are seeing more and more fuel geysering that result in injuries, 17 at last count in the last 3 years. The lawyers are starting to say it will probably be better replace all of the chainsaws rather than continue to use them. If the Forest Service makes that call, we will most likely have to follow suit. In the meantime, we are required to add a fuel geysering section to our training. They will also be printing shortly, safety labels for the chainsaws and fuel bottle that will be required. Also looking at a 3rd party refueling system. It is the same people that make the fuel caps for race cars. The bottle will have a nozzle that fits into the new fuel cap. It takes 2 seconds to fill the chainsaw and there is not one drop of fuel leakage. Spent 1 full day in training on human factors in accidents. Discovering that it has a much bigger impact than we originally thought. On bucking, we have always used the same term as felling: "escape

route" in bucking is "safe quadrants or zone". Escape route implies moving, but you general stay in one safe spot. Starting to much more particular in their training and words.

 - Dana: Travel Oregon funded a study to advocate for a state wide trail. Washington has WTA. Oregon doesn't have that. It would be a non-profit I assume. There is someone that did a study, Stephanie Knoll, to see if would be a good opportunity.
 - Becky: ORTEC which is kind of the counter part to the Washington one. I'll find out more.
- Claire Fernandes: I was thinking about requesting funding for NYC (northwest youth corp) to do work on the Timberline Trail. I think we could probably do about 8-10 weeks of work on the trail with a youth crew (or possibly less, need to look into it more). This would be really costly, but would help us address some issues that have been problems for years. In addition to requesting funding to do this work, we have to have a 20% match. This 20% match could come from Forest Service staff time, as well as volunteer work from partner groups. If you guys are interested, I think we could all sponsor the proposal and match. In addition to being FS admin time lining the crews out etc., there could be partner time working on feeder trails to the Timberline Trail. If funds were approved, work would most likely occur in 2018.
